INSTRUCTIONS AND PROCEDURE FOR SEALING AND EXPUNGING JUVENILE RECORDS

TRAFFIC

1. Fill out the Application completely.

2. File the completed Application with the Juvenile Traffic Clerk of Courts at:

399 S. Front St. Columbus, OH 43215

3. Your case/cases will be scheduled for hearing before a magistrate to determine whether the application should be granted. You will receive the hearing date after filing your application.

The Prosecutor will receive a copy of the Application and will be present at the hearing.

4. You have the right to be represented by an attorney at the hearing. A parent or attorney must accompany you to the hearing if you are under 18.

When you attend your hearing, make sure to bring any relevant information or documentation with you, beyond what was referenced in your Application.

5. If you fail to appear for your hearing, your Application will be dismissed.

6. After the hearing, you can expect a Judgment Entry within a week.

DELINQUENCY/UNRULY

1. Fill out the Application completely.

2. Bring the completed Application to the Juvenile Prosecutor's Intake Department at:

399 S. Front St. Columbus, OH 43215

3. If the Prosecutor does not oppose your Application, it will be granted. You can expect a Decision and Judgment Entry within 2 weeks.

4. If the Prosecutor opposes your Application, your case/cases will be scheduled for hearing before a magistrate to determine whether the application should be granted. A notice of hearing will be mailed to you once the hearing is scheduled.

5. You have the right to be represented by an attorney at the hearing. A parent or attorney must accompany you to the hearing if you are under 18.

When you attend your hearing, make sure to bring any relevant information or documentation with you, beyond what was referenced in your Application.

6. If you fail to appear for your hearing, your Application will be dismissed.

7. After the hearing, you can expect a Decision and Judgment Entry within 2 weeks.
